## Minister's message

I am pleased to present Agriculture and Agri-Food Canada's (AAFC) report on fees for 2022–23.

The *Service Fees Act* provides a modern legislative framework that enables cost-effective delivery of services and, through better reporting to Parliament, improves transparency and oversight.

AAFC's Fees Report provides information on nine fees out of which one is set by contract/agreement and the rest are set by act, regulation or fees notice. The fees support services from Business Risk Management Programs to the Canadian Pari-Mutuel Agency (CPMA) to the Research and Development Centre.

Due to the COVID-19 pandemic AAFC's revenue generating services and activities were directly impacted resulting in less revenues and costs for 2020–21. In 2021–22, facilities reopened thereby generating higher revenues and costs compared to 2020–21 but still not reaching pre-pandemic levels. In 2022–23, revenues and costs increased as activities and services were back to operating at almost pre-pandemic levels.

I invite you to review this year's report, which further advances our key objectives of open and transparent fee management. I will continue to lead my department's transition to the reporting regime provided under the *Service Fees Act*.

## About this report

This report, which is tabled under section 20 of the *Service Fees Act*, the [Low-Materiality Fees Regulations](#)<sup>ii</sup>, and subsection 4.2.8 of the Treasury Board [Directive on Charging and Special Financial Authorities](#)<sup>iii</sup>, contains information about the fees Agriculture and Agri-Food Canada had the authority to set in fiscal year 2022–23.

The report covers fees that are subject to the *Service Fees Act* and exempted from the *Service Fees Act*.

For reporting purposes, fees are categorized by fee-setting mechanism. There are three mechanisms:

1. Act, regulation or fees notice  
The authority to set these fees is delegated to a department, minister or Governor in Council pursuant to an act of Parliament.
2. Contract  
Ministers have the inherent authority to enter into contracts, which are usually negotiated between the minister and an individual or organization, and which cover fees and other terms and conditions. In some cases, that authority may also be provided by an act of Parliament.
3. Market rate or auction  
The authority to set these fees is pursuant to an act of Parliament or a regulation, and the minister, department or Governor in Council has no control over the fee amount.

For fees set by act, regulation or fees notice, the report provides totals for fee groupings, as well as detailed information for each fee. For fees set by contract, the report provides totals only. Agriculture and Agri-Food Canada did not have fees set by market rate or auction.

Although the fees Agriculture and Agri-Food Canada charges under the [Access to Information Act](#)<sup>iv</sup> were subject to the *Service Fees Act*, they are not included in this report. Information on Agriculture and Agri-Food Canada's access to information fees for 2022–23 is in our annual report to Parliament on the administration of the [Access to Information Act Agriculture and Agri-Food Canada Annual Report to Parliament –Access to Information Act and Privacy Acts](#)<sup>v</sup>.
